DAIRY RESTAURANTS

The  makes much effort with certifying restaurants to ensure that the highest standards of Kashrus are adhered to at all times. Consumers may be mistaken in thinking that dairy restaurants do not pose a problem when it comes to Kosher certification. Recently, the Vaad was approached to certify a restaurant that had previously been certified as dairy, cholov yisrael. Upon our visit, items such as shortening, chocolate discs & margarine labeled dairy not cholov yisrael were found. In addition, bakers glaze not bearing a hechsher was also found. It is important that fish being purchased by restaurants come in with simanim (signs of Kashrus). Filets of fish must come with a reliable hechsher. Products marked with a  Kosher certification and the letter D signify that the product is not Cholov Yisrael. Kosher supervisors, must be vigilant in this respect and watch each and every single ingredient exactly as they would in a meat restaurant. Kashrus stringencies are equivalent in both of these cases. By constant inspection the Vaad will ensure that our restaurants adhere to our standards under the supervision of our mashgichim and in conjunction with our inspectors. We are pleased to increase the amount of restaurants under our supervision and encourage consumers to support them.
